AFINANCIAL REPORT:

NO FINANCIAL REPORTS DUE TO END OF YEAR CLOSINGS.

Year-end financials were submitted ahead of the deadline to HUD's portal, REAC. Information required by the Auditors was provided, and they can commence substantive testing to complete the audit FY2024.

DIRECTORS REPORT:

- E.D. Gober indicates that early afternoon on 2/16/25, HAGC/GHA's Property Manager issued a notice to all maintenance personnel regarding possible maintenance issues due to high winds. At approximately 6:30PM GHA received a notification from the Gloucester County Office of Emergency Management (OEM) that Delsea Manor was without power. GHA monitored the situation, and staff surveyed the residents. A mandatory evacuation order was issued by OEM for all 40 units, some residents chose to go with friends/family and GHA coordinated stays at the Residence Inn located in Deptford NJ. Twenty-six residents were checked into the Residence Inn, however, since GHA is a public body and is not allowed to maintain a credit card account, E.D. Gober utilized her personal card to make the reservations and cover the expenses. A motion was made by Vice Chairman Jacob Hines and seconded by Commissioner Thuraisingham Mohanakanthan to approve a reimbursement of total expenses incurred by E.D. Gober while responding to the emergency.
- Electric was restored on 2/17/25 and with coordination with OEM the residents were able to return
 to their units. Commissioner Andrew Halter comments on the cooperation between OEM, the Red
 Cross, Glassboro's Police and Fire departments and HAGC/GHA personnel in taking care of the
 emergency.
- E.D. Gober indicates while Wolfschmidt was onsite at Williams and Grillo for boiler maintenance, two cracks where found and emergency repairs were needed, RES 2025-16 asks the board to ratify the emergency repairs.
- E.D. Gober indicates the Federal Continuing Resolution expires on March 14, 2025.
- E.D. Gober indicates the Office of Management and Budget funding freeze did not affect GHA operations; the funding freeze was later withdrawn.
- HUD Secretary Scott Turner has been appointed.
- E.D. Gober indicates the NJNAHRO is having a conference April 27-30th, if any Commissioners are interested in attending, contact Executive Assistant Nelly Rojas.
- E.D. Gober discusses GHA non-payments of rent, repayment agreements and evictions.

No further questions from the Commissioners.
