AFINANCIAL REPORT:

Accountant, Michael Jezierski provides a brief financial report indicating that total assets and total liabilities have decreased, GHA has paid administrative fees from October 2024 through March 2025. Receivables have increased, as of April 30th the receivables total \$35K as follows: \$1K DM, \$14K Williams, \$20K Grillo. Overall, GHA is profitable. Salary, wages, and fringe benefits have increased with the hire of a new employee for home support. GHA's audit is currently underway. E.D. Gober indicates that the state has not released the report for the unfunded pension liabilities, which will be an adjusting entry from the year end entries. E.D. Gober indicates the overall rent collections for April is 53.27% and the agenda contains Resolution 2025-30, asking the Board to consider the write-off of uncollectible rents. GHA will pursue eviction for nonpayment of rent as a last recourse.

DIRECTORS REPORT:

- E.D. Gober indicates HUD has issued funding notices for the Housing Choice Voucher (HCV) Program, the HCV Program was awarded a 4% inflation factor, news articles are included in the Board Packets.
- E.D. Gober indicates the State passed new requirements regarding affordable housing, an article in the Board Packets discusses a group of towns in NJ that are filing a lawsuit in federal court against the State as to how the State is calculating the municipalities affordable housing obligations. Glassboro is a zero and has met this obligation.
- E.D. Gober indicates a meeting is scheduled with the Borough of Glassboro regarding future development, the managing of GHA properties and how to improve, and the parcel of land on Higgins.
- E.D. Gober summarizes the remainder of the agenda, RES 2025-29 involves monthly expenses, RES 2025-31, 2025-32, 2025-33, and 2025-34 ask the Board to consider extending participation with purchasing cooperatives. E.D. Gober indicates even if GHA is not required to bid for services, we make sure the purchase is competitive. RES 2025-35 recommends power washing for Delsea Manor, Williams Street and Grillo Street properties.
- E.D. Gober advises the Board that roof replacement is needed at Summit Park and is estimated to cost about \$20K.

- E.D. Gober thanks the Commissioners who attended the NJNAHRO Conference.
- There is a discussion on the proposed federal budget and rental increases.
- E.D. Gober reminds all that Delsea Manor is a polling location for the June 10, 2025 Primary Flection.
- E.D. Gober indicates that Inspira LIFE was onsite at GHA on May 15, 2025 to present to GHA residents.
- GHA Site Manager, Barbara Nicholson discusses the Garden Club.
